The Midwest Row Crop Collaborative (MRCC) is comprised of a diverse group of organizations working to expand regenerative agricultural solutions that enhance soil health and water quality and reduce greenhouse gas emissions while remaining committed to producing food, fuel, and fiber to support the growing global population. The leading organizations that comprise its membership are committed to working within our U.S. food and agricultural system to deliver environmental outcomes at a meaningful scale throughout the Mississippi River Basin.

With a smaller membership by design, MRCC develops innovative solutions for removing barriers to the widespread adoption of regenerative agricultural practices in a collaborative and precompetitive environment. Approaches tested by members include designing conservation finance solutions and other strategies to derisk practice adoption, using social science to support and promote regenerative approaches, and developing specific supply chains for crops produced with regenerative practices.

Project: Expanding a PepsiCo and Unilever cost share program delivered by Practical Farmers of Iowa in Nebraska and Iowa by collaborating with Cargill.

Policy: Developing collaborative federal policy recommendations and collectively meeting with federal policy makers on Capitol Hill in advance of the 2023 farm bill.

Partnership: Working through the Scale Lab to develop resources for companies who want to contribute to the growth of regenerative agriculture.

Annual dues - 2024

Annual project investment

\$150,000 (direct payment or in-kind) toward systems change projects within 24 months of joining and each year of membership.
